### Review of Urban Pest Management unit standards

#### **Summary**

The unit standards in the Urban Pest Management domain are under review. Drafts for new versions of the standards are now available for feedback and comment.

The initial consultation phase has not identified any significant issues with the outcomes and performance criteria; however, the review identified areas where the clarity of language can be improved. The draft standards incorporate changes to incorporate initial feedback, improve clarity and assessibility, and make other technical improvements.

It is not intended that significant change should be required to programmes incorporating these standards as a result of changes made at review. It is requested that industry note any unintended consequences of redrafting and provide feedback during this consultation phase.

# Main changes

- Titles have been amended for clarity and to reflect changes to standards.
- The guidance information has been updated to reflect current legislation, regulations, references, and definitions.
- Outcomes have been amended to clarify their intent.
- Performance criteria have been amended for clarity and alignment with outcomes. Qualitative
  measures which apply generally (read: in accordance with worksite procedures) have been
  moved to range statements in the guidance notes.
- The Hazardous Substances (Hazardous Property Controls) Notice 2017 (EPA Notice) was added to the assessment requirements for standard 28787,
- Reference to the Wildlife Act 1953 was included in standard 28787.
